## **Applewood Golf Course**



Prospect Recreation & Park District Purchased the Applewood Golf Course

On December 20, 2016, Prospect Recreation & Park District acquired ownership of the Applewood Golf Course from the Coors Brewing Company, a subsidiary of Molson Coors. This purchase was the culmination of almost two years of effort by an incredible number of people and organizations. All of us at Prospect extend huge thanks to the entire PRPD community- your vote to approve the \$9 million Bond issue in November 2015 was absolutely critical in allowing Prospect to assemble the necessary financing to complete the purchase. Additional funding for the purchase was comprised of a \$1.1 million Local Park and Recreation grant from Jefferson County, a \$3 million Protect Initiative grant from Great Outdoors Colorado, and PRPD general fund monies. The cash purchase price was \$13.5 million, with Coors Brewing Company generously agreeing to a "bargain sale" and making a charitable donation in the amount of \$1.5 million. Thank you to Jefferson County Board of Commissioners, Jefferson County Open Space, Great Outdoors Colorado, the Colorado Lottery, Coors Brewing Company, Molson Coors, the Coors family, and especially to the residents and voters of Prospect Recreation & Park District! And special thanks go out to The Trust for Public Land (TPL), Prospect's partner on the acquisition. Hillary Merritt, Project Manager for TPL, was absolutely instrumental in ensuring that the effort was ultimately successful.

## **Applewood Golf Course (Continued)**

The list of those who assisted and participated in the effort to acquire the Applewood GC is a wonderful example of a community collaboration. The effort extended far beyond the local Applewood and Fairmount communities and Prospect Recreation & Park District. Homeowners groups, community organizations, politicians, golfers' young and old, individuals, and many, many others all gave of their time, expertise, energy, and money to make the preservation of the Applewood GC a success. As part of the acquisition, Prospect assumed the existing lease between Coors and Touchstone Golf, LLC. Touchstone has been operating, managing, and maintaining the Applewood GC since 2007, and has done a wonderful job during that time. For at least 10 years into the future, and hopefully longer, Touchstone will continue their operations at Applewood, with Prospect as the new property owner. Based on the requirements of the grants that Prospect received, the Applewood GC site must always remain a golf course, open space, or be used for recreational purposes. It can never be converted to any type of residential, commercial, or industrial use.

Prospect is in the planning stages for a multi-use trail that will run along the east side of the course to connect W. 32nd Avenue to the Clear Creek Trail. Prospect will also be undertaking a Master Plan for the Applewood GC site. Golf is obviously the main function at Applewood, but it is possible that additional recreational opportunities could be added in the future.

The Save Applewood Golf Course (SAGC) coalition, a group formed with the goal of preserving the Applewood GC, made a donation to PRPD of slightly more than \$12,000. These funds were left over from the SAGC's fundraising efforts, and were donated to PRPD with the stipulation that the funds be used specifically at Applewood.

The Prospect Foundation, a 501c(3) organized to benefit PRPD, made a donation of \$5,000 to PRPD in support of PRPD's acquisition of the AGC. PRPD gratefully appreciates the donations from both of these wonderful organizations, and will ensure that the funds are put to good use at Applewood.
